Op Ed: The Oppression Olympics

The Uyghurs, a Muslim minority community in China's Xinjiang province, are facing genocide. There's well-documented evidence of mass concentration camps, forced labor, sterilization campaigns, forced marriages, and more — all designed to destroy any semblance of ethnic or religious identity. A new analysis of Chinese state papers has demonstrated that the genocide goes all the way up to the very pinnacle of Chinese state leadership. Xi Jinping himself in 2014 ordered, "Those who should be seized should be seized, and those who should be sentenced should be sentenced."

The Uyghur genocide is a stain on the global conscious. Meanwhile, China is preparing to host its second Olympics in 14 years just as Xi has consolidated power. Last month, the Chinese Communist Party Central Committee elevated Xi in a move that could keep him in leadership for long into the future.

for the Chinese government — namely Xi — to flex their muscle on a global scale. Beyond the medal count, they aim to showcase the quality of their infrastructure, their COVID-19 response, and their global influence as they host. Which is why the Biden administration's decision to issue a diplomatic boycott of the Games over the genocide in Xinjiang is an important move. Yet U.S. efforts to sanction powerful governments over their human rights abuses are so rare as to make this an exception that proves a rule.

It forces us to ask: why here, why now, and why not elsewhere?

High-level officials from countries around the world customarily attend the Olympic Games as a show of international goodwill. The diplomatic boycott would mean that no U.S. official would attend, though U.S. athletes will be allowed to compete under the flag. The boycott also forces American allies to follow suit or be seen as turning a blind eye to the Chinese government's human rights abuses. Indeed, the U.K. and Canada have already announceddiplomatic boycotts of their own. Make no mistake, the

diplomatic boycott of these Olympic Games is an important step to holding the Chinese government accountable for its genocide against the Uyghurs.

But the broader context of the U.S. relationship with China and our country's record on human rights abuses elsewhere paint it in a far less flattering light. First, this diplomatic slap in the face sits far short of the kind of action that really forces the Chinese government to bear the costs of their human rights abuses. Toward that end, the House passed a new bill that would ban imports from Xinjiang unless customs officers could verify that they were not manufactured at the hands of forced laborers. It also forces regular disclosures from companies doing business in the region. The bill now moves to the Senate where it has

rights." The U.S. record on human rights abroad fails to maintain any clear standard and our failure to take on human rights abuses elsewhere casts a long shadow over our country's efforts to take on human rights abuse anywhere. While the suffering of the Uyghurs is profound and deserves a response, it's too easy to cast aspersions on U.S. government activism for the Uyghurs as a convenient ploy to attack an emerging competitor for global power on the world stage than honest efforts to protect an oppressed ethnic minority.

Indeed, the U.S.' decades-long history of coddling human rights abusers in Egypt, Saudi Arabia, and Israel are telling. It's well known that Egyptian state security operated by the dictatorial regime in that country routinely uses arbitrary detention, sham trails, sexual assault, and other tools of intimidation to silence criticism. Yet rather than sanction Egypt, we prop up their military to the tune of billions a year. Jamal Khashoggi was murdered and dismembered at a Saudi Consulate in Turkey by a 15-man hit squad on orders directly from the very top of the Saudi

government. The Saudi government runs on a foreign workforce who are routinely denied their basic rights. They have perpetrated war in Yemen that has caused mass famine, killing thousands of children. Instead of holding them accountable, we have subsidized their military. Israel maintains an illegal occupation of Gaza, East Jerusalem, and the West Bank that relies on economic blockade, forced removal, and regular state violence.

While I applaud the Biden administration and Congress for their action on the genocide in Xinjiang, I have to ask: why aren't we pursuing similar actions against ostensible allies who are violating human rights, as well? My point here is not that the U.S. shouldn't be doing all it can to hold the Chinese government accountable — indeed it must do more. We should be doing all we can to hold human rights abusers accountable around the world.

These Olympics, like all international sporting events, are about more than just athletics. They're an opportunity broad bipartisan support.

However, comments from the Chinese Ministry of Commerce's spokesman exploit an unfortunate central tension in our selective attention to human rights. Predictably blasting the bill, he called it another example of the U.S. "masquerading unilateralism, protectionism and bullying as concerns for human

Our commitment to our ideals shouldn't end where our foreign policy interests begin. Rather, our foreign policy interests should begin with our ideals.

Op Ed: Freedom Of Expression

One of my friend sent a message through "WHATSAPP"

"Raise your voice....."

When you attack black people they call it racism. When you attack country, they call it terrorism. When you attack homosexuality, they call it intolerance. When you attack women, they call it gender discrimination. When you attack Jews, they call it anti-Semitism. But when they attack Holy Prophet #Mohammad (P.B.U.H) they call it freedom of speech.

My humble response is: Let us follow the Quranic guidelines and footsteps of our holy prophet Muhammed (PBUH)

In October 2020, a young Chechen immigrant Abdullah Anzorov beheaded Samuel Paty, a schoolteacher in France who was showing cartoons of prophet Muhammed published in the French magazine Charlie Hebdo which were offensive to Muslims.

Abdullah was shot dead by the police and French president conferred the highest civilian award posthumously on Samuel Paty as a sign that the country stands by his courage and conviction. Abdulla's act was inspired by certain teachings of Islam which command its followers to kill anyone disrespecting the Prophet.

French reaction: There was a shutdown of grand mosque in Paris along with several other mosques all over the country. Many Islamic organizations were closed, and many imams and Muslim leaders were deported. French people believe that the refugees fleeing from North Africa to Europe are bringing their Islamist culture with them causing social stress. France implemented a law which seeks to ban mosques from receiving foreign finances, limit homeschooling and prevent foreign imams from preaching in French mosques. Unfortunately, Muslims are losing their rights as the citizens.

In western secular societies an individual has a right to ridicule the religion or Prophets, but they should show the sensitivity and wisdom knowing that this indecency will be upsetting to hundreds of millions of people in multicultural societies? We do not insult Holocaust victims; we do not insult Rev. Martin Luther King by using "N" word. These acts



are insensitive, hurtful, and may result in violent reaction. How you make a distinction between "Free Speech, mockery and Hate Speech". In multicultural societies –cultural sensitivity, ethnic and political awareness is a must for maintaining harmonious relationship in a multi-cultural society.

FREEDOM OF expression; The majority French and minority Muslim cultures have different interpretations of freedom of expression. Muslims believe that humiliating prophet of Islam is a form of oppression whereas for French freedom of expression supersede the sanctity of religious beliefs. The best way to resolve the issue is through the dialogue, not only among intellectuals but the grassroot to understand each other's cultural perspective and religious sensitivity.

Quranic verses do not prescribe punishment for Blasphemy "If you hear God's revelations being mocked and ridiculed, don't be with them unless they delve into another subject. Otherwise you will be as guilty as they are. God will gather the hypocrites and the disbelievers together in Hell" (4:140) "But indeed, they uttered blasphemy. If they repent, it will be best for them. But if they turn back (to their evil ways), Allah will punish them" (9:74)

The Prophet's advice for blasphemers. Suhail bin Amr, the poet, blasphemed the Prophet but the Prophet asked his Companions to treat him kindly after he was captured during the Battle of Badr. The Prophet also rejected his companions' advice to execute Abdallah bin Ubayy, the chief hypocrite, because "People will say that Muhammad kills his Companions." If Blasphemy was punishable by death under Sharia, then MOST of the population of city of Makkah would have been put to death when Muslims conquered the city. The citizens of Makkah committed blasphemy against Prophet Muhammed, Islam and Allah (swt). Prophet Muhammed set an example by showing mercy and forgave all of them. Let us follow the footsteps of our beloved **Prophet Muhammed (pbuh)**, a symbol of mercy to man-

New Mexico Mosque Set On Fire In The Latest Incident Of Islamophobia In U.S.

As hate crimes against people of color continue across the country, members of faith centers and organizations are bearing the brute of it. Faith institutions across the country are facing hate crimes at alarming rates, with an Islamic center in Albuquerque, New Mexico having reported the latest incident.

Multiple fires were set near the prayer hall of the Islamic Center of New Mexico by a woman, according to a surveillance video, local news outlet KOB 4 reported. The fire also spread to the facilities playground.

"So this is her in the corner right here," Ayman Musleh, the facilities director at the Islamic Center of New Mexico told KOB 4. Musleh showed the news outlet a video of what appears to be a woman wearing a black hoodie setting multiple fires Monday morning. In the footage, the woman can be seen lighting some trash on fire in a garbage bin before tipping it over.

While the woman has not yet been identified worshippers believe it may be connected to a woman who showed up at the center last week and was hostile towards them.

"For us to see that anybody could just walk in and do this, we just don't feel safe," Aneela Abad, the center's general secretary, said. "It's a hate crime. It's very targeted towards Muslims. Islam is, the word Islam, means peace. We stand for peace."

While the woman walked away almost immediately after starting the fire, some men who were working across the



extinguisher." Abad also noted that these people reminded the worshippers of the good in the world.

While the crime is being investigated by the FBI and local authorities, it has not yet been declared a hate crime. Advocates and local civil rights groups are thus calling for an investigation as such. Hate crimes are defined by the FBI as crimes "motivated by bias toward race, ethnicity, ancestry, religion, sexual orientation, disability, gender, and gender identity."

The Council on American-Islamic Relations (CAIR), the nation's largest Islamic Muslim civil rights and advocacy organization, is among those who have called on local and federal investigators to view the incident as a hate crime.

"Given recent hate incidents targeting mosques and prominent American Muslims, New Mexico law enforcement authorities and the FBI should investigate a possible bias motive for this incident," CAIR National Communications Director Ibrahim Hooper said. "Silence and inaction in the face of growing hate nationwide only provides encouragement to bigots targeting all minority communities." Worshippers also believe the center was targeted because it is the largest and oldest Islamic center

in the state.

"This was not just a normal crime. This was crime on the religious institute," Tahir Gauba, a mosque goer, said. "She came in with the agenda of burning down this place of worship."


"Now the families, they are actually scared to bring the kids here," The Center's Director of Education Reda Hussain Elkomy noted that while the community has always been open to bringing their families, "now the families, they are actually scared to bring the kids here."

Members of the community are now afraid because this is not the first but second time the mosque has been targeted. According to KRQE News 13, someone threw a Molotov cocktail at a wall, scorching a section of the building in 2014. "We don't partake in violence and we don't condone it, and we speak out against it," the center told KRQE News 13 at the time of that incident.

The latest incident follows a similar incident in Washington state last week, in which a video released by the state's local CAIR chapter found that a car drove up to the Islamic Center of Olympia and tossed an explosive device on the ground in front of the mosque.

CAIR is thus urging houses of worship to take extra security precautions and to use its "Best Practices for Mosque and Community Safety" booklet. The advice in CAIR's security publication is applicable to religious institutions of all faiths. The booklet may be viewed at:

Additionally, a new survey exploring the lives of Muslim Americans found that more than two-thirds of U.S. Muslims personally experienced Islamophobia, Daily Kos reported. The survey supports data compiled by the FBI which found that hate crimes in 2020 were reported at a significantly higher rate than those in 2019.

Several School Districts Close In Aftermath Of Oxford Shooting

On Tuesday Nov. 30, there was a school shooting in Oxford, Michigan in which 4 students passed away and 8 others were injured. In fact, this was the deadliest school shooting of the year. Oxford is located in Oakland County and is about 45 minutes Northwest of Detroit.

According to The Detroit Free Press, a 15 year old student Ethan Crumley was arrested on suspicion of the shooting and is facing charges including murder and terrorism.

According to the Free Press, the victims of the shooting were "Tate Myre, 16, Hana St. Juliana, 14, Madisyn Baldwin, 17, and Justin Shilling, 17" and "are being remembered as athletes, an honors student and an artist." Additionlally, there are possible charges against the suspect's parents for not properly securing



firearms. Since then, there have been many threats of copycat shootings which have led to school closures.

In the aftermath of mass shootings, there is a very real possibility of copycat attacks and there are definitely threats that occur. In fact, there have been several threats on social media in direct aftermath of this shooting in the Metro Detroit area with Sheriff Michael Bouchard saying "If you're making threats, we're going to find you," and "It is ridiculous you're inflaming the fears and passion of parents, teachers, and the community in the midst of a real tragedy."

As a result of these threats, many school districts have closed out of an "abundance of caution" including Bloomfield Hills School District, Holly Area Schools, Rochester Community Schools, Troy School District, Warren Consolidated Schools, Clarkston Community Schools and Lake Orion Community Schools."

According to Click-OnDetroit, "School districts across Michigan are reevaluating their emergency preparedness plans in the wake of the deadly shooting on Tuesday at Oxford High School."

Right now, the schools undergo the following

training: "As it stands, the district has its staff regularly undergo ALICE (Alert, Lockdown, Inform, Counter, Evacuate) active shooter preparedness training and each school in the district practices drills for this type of scenario." The idea is to make sure people are prepared for the real possibility of such shootings occurring again.

Right-Wing Media Outlets Wrote False Reports On This Muslim Prosecutor Then Conservatives Threatened Her

One of the first Muslims to be elected to public office in Virginia has come under attack after right-wing media outlets chose to target her and create false narratives around her work. Elected in 2019, Buta Biberaj unseated a Republican incumbent for Loudoun County's commonwealth attorney position. As gubernatorial elections neared in Virginia, conservative media outlets used a former sexual assault case involving a Loudoun County school to spread disinformation about Biberaj and others.

According to the American Independent Foundation, the false accusations boosted by Republican gubernatorial candidate Glenn Youngkin accused Biberaj of attempting to cover up the sexual assault by silencing the father of the victim by having him arrested and pocketing money from investor George Soros. As a result of these conservative lies, Biberaj has received death threats on her personal cell, home, and office numbers.

Callers have left threatening messages like: "We're coming for you, bitch," "You don't have to watch your back, we're going to come at you from the front," and, "You deserve everything you're going to get."

"Those individuals are highlighting the fact that I'm a woman, I'm of the Muslim faith, I'm ... an immigrant," Biberaj told the American Independent Foundation. "We've had threats and comments and harsh communication from white supremacist groups. So you see that and know

According to the American Independent Foundation, the following day the organization shared the article in a tweet that called Biberaj a "Soros-backed immigrant Muslim prosecutor who is trying to jail a white father." Six days later, the VDARE account replied to a tweet from the Youngkin campaign about ties between Biberaj and Soros and said that she was "an Albanian Muslim immigrant from Montenegro."

The Southern Poverty Law Center references VDARE as "anti-immigration hate website" that "regularly publishes articles by prominent white nationalists, race scientists and anti-Semites."

Right-wing media outlets including Fox News and the Daily Wire used the Loudoun County sexual assault case as justification of why trans people should not use bathrooms that match their gender identity. They claimed that cisgender males would masquerade as trans females to assault girls in bathrooms and locker rooms and used this case to argue for "bathroom predator" myths.

While the boy charged in the case was reportedly wearing a skirt at the time of the assault, Biberaj said, he did not identify as transgender during the trial, and the assault took place after the girl had invited him to meet her in the bathroom. He then "exceeded the permission and consent of the girl, which is what made it sexual assault," she said.

A judge ruled against the boy on Oct. 26 in his first of two cases of sexual assault in the county.

Right-wing media outlets then claimed that the victim's father was also arrested because Biberaj wanted to silence him even though reports found the father was arrested on charges of disorderly conduct and resisting arrest after a fight broke out at a school board meeting in June.

In an alleged "fact check," the Republican Standard wrote on Oct. 27 that Biberaj "must have understood why Smith, who attended a Loudoun County School Board meeting on June 22 looking for answers, would've gotten upset after the district superintendent said the student suspected in his daughter's assault didn't exist. And yet, she appeared in court personally to push for jail time, a fine

and anger management classes."

Conservative outlets have continued to highlight her immigrant background, referring to her as not American as they make statements saying an immigrant prosecutor arrested an "American who complained about daughter's rape."

As the right-wing media lies spread, threats against Biberaj increased. When she brought them to the Virginia attorney general's office, the Virginia State Police, and the FBI, she was advised to reevaluate the way she lives her life in order to protect her safety.

"The narrative just keeps changing to fit what the goal is ... If you look at everything that's out there, we knew nothing about the May 28 incident until July 9," Biberaj said. "So all those narratives are intentional disinformation."

leaders to create healthy communities. When individuals take incidents like this which are harmful, hurtful, as well as traumatic to families, and you're going to take that and let that be your rally cry, just to promote something, then that means your political interests are greater than your people interests," Biberaj said. "And, that to me, is not a sign of good leader[ship], because once this election is done, I don't think Mr. Youngkin or any of the candidates may be in our day-to-day lives here in Loudoun County. But these families are still living here. The hurt that they're causing will still reside here."

"That's not leadership," she added.

According to Loudoun Now, investigations are being conducted in regards to the threats.

"The Virginia State Police is in receipt of the threats and has forwarded them to our Behavioral Threat Assessment and Management Team, as is done with any email of an alarming/ threatening nature that is received by an elected/ public official. No arrest or charges have been placed at this time," a statement from the State Police said.

But individual people are not the only ones threatening Biberaj; hate groups like VDARE are campaigning against her as well. Hundreds Of Demonstrators Across U.S. Protest Facebook's Role In Anti-Muslim Hate Speech

WASHINGTON, DC (Nov. 14, 2021) – Hundreds of people of different faiths, professions and backgrounds gathered in eight major U.S. cities Saturday and Sunday to protest Facebook allowing hate speech to be freely posted in India, resulting in persecution, physical attacks and killings of members of non-Hindu minority religions.

The protests, organized by India Genocide Watch, featured speakers demanding that Facebook's founder-CEO Mark Zuckerberg end his company's complicity in extreme Hindu rightwing incitement to violence, proliferating on Facebook and WhatsApp, as exposed by whistleblower Frances Haugen.

Protest demonstrations, that also included women and children, were held in Atlanta, Chicago, Charlotte, Houston, Los Angeles, San Diego, Seattle and San Francisco's Menlo Park, where Facebook is headquartered.

Many of the protesters, who can never return to India, have family in India who are targets of state-sanctioned persecution, discrimination and physical violence.

Omicron: Emerging Answers To The Three Big Questions

Just as much of the country was settling into that tryptophan-induced Thanksgiving slumber, news emerged out of South Africa of a new SARS-CoV-2 variant of concern. The World Health Organization has dubbed it omicron.

To add to the panic, news of the variant tanked the global market at Friday's opening bell. The U.S. announced a partial travel ban from eight Southern African countries following leads from countries across Europe. As scientists rush to understand the new variant, it's been discovered in 15 countries and counting, including right on our doorstep in Ontario, Canada.

Beyond the panic, there are more questions than answers. Let's cut in to the three most important questions to understand their implications.

Is it more transmissible?

The reason why scientists and the WHO are so concerned about omicron, is that it has up to 50 mutations, 30 of them on its spike protein — the piece of the virus that allows it to dock onto our cells. It borrows some of these mutations from the delta variant and some from the beta variant, and nearly half are altogether new. Taken together, they may make the virus more transmissible and more antibody resistant.

The metric to pay attention to regarding transmissibility is what epidemiologists call "enrichment," or how fast the variant overtakes other strains to make up the majority of new COVID cases. Indeed, within two weeks of first being identified in South Africa, it has overtaken all other variants. That's extremely fast. That said, cases were relatively low in South Africa prior to omicron's emergence, suggesting the variant had relatively little competition. It will face a lot more as it inevitably spreads in European countries facing far more active



delta spread right now. That will teach us more about its enrichment and transmissibility.

Is it more vaccine resistant?

The second question is about vaccine "escape," or resistance. Though there is circumstantial evidence of cases among double-mRNA-vaccinated people, we are still waiting on studies from vaccine manufacturers. These come in two forms, in vitro studies which will look at the reactivity of antibodies from the blood of vaccinated people to the virus, and in vivo studies that will look at the relative risk of breakthrough infection among vaccinated people relative to unvaccinated people.

I want to be clear about something. Though it has some frightening new mutations, omicron is still SARS-CoV-2. It shares most of the same fingerprint with its original cousins, which means that though the new mutations may render our vaccines less effective, it's extremely unlikely to render them ineffective. So as you hear experts talking about vaccine escape, don't assume that to mean complete escape. Nevertheless, major manufacturers are already beginning the process of designing boosters that specifically target omicron. Indeed,

of mRNA technology is that redesigning vaccine payloads is relatively simple, involving changing out or adding to the mRNA sequence. Pfizer's spokeswoman said that the company "can adapt the current vaccine within six weeks and ship initial batches within 100 days in the event of an escape variant." Moderna has suggested a similar timeline.

To the unvaccinated, omicron raises even higher concern. One of the most common excuses that the unvaccinated make is that they already "have antibodies" from a previous infection with COVID. But acquired immunity tends to be more specific to the variant with which an individual was infected and less durable over time. Considering that the appropriate course of vaccination for adults is now three doses, the advantage of vaccine-mediated immunity over acquired immunity in the setting of omicron is

ation said, "we don't see severely ill patients." That said, that evidence is highly circumstantial. The majority of early omicron patients have been relatively young, and therefore less likely to suffer severe COVID symptoms in the first place. There's a lot more science between here and a rigorous answer regarding the severity of omicron. As omicron infects a broader swath of the population, we'll learn more about its severity.

The emergence of a more transmissible, less severe variant of the virus is in keeping with the evolutionary pressure on viruses in the first place. Permit me some personification here: the virus's "goal," evolutionarily. isn't to make you sick — it's to spread to as many people as possible. Toward that end, evolving for transmissibility makes obvious sense. But so does evolving against severity. More severe illness both

emerged. This variant infected so many people that the majority of the population acquired immunity, reducing the number of vulnerable hosts and ending the pandemic. Yet there remains substantially more to learn about the severity of this variant, and the trajectory it could have on this pandemic overall.

What does it mean?

The consequences of this pandemic, as we've discussed, are not limited to the virus itself, but all the ways the virus has interrupted our lives. For many, last week offered a glimpse of what going back to normal could be. And yet, nearly two years into this, as "over" the pandemic as we may be, the pandemic isn't yet over with us.

Whatever we learn about omicron's capacity for vaccine escape, vaccines will remain the most important tool in our arsenal. That can't just mean a three-dose vaccine for folks at home, but massive access to vaccines abroad. It also means that tools we have yet to use effectively — like mass testing and contact tracing — are particularly critical now.

Is it more severe?

Thankfully, early, though circumstantial, evidence suggests that that's unlikely. South African doctors who first treated omicron patients have suggested that disease severity could even be lower than other variants. First Female Lieutenant-General Appointed In Pakistan Army

2021 was a historic year for Pakistan. The Pakistan army appointed its first female Lieutenant-General. Speaking on occasion, Pakistan Army's Chief of Staff General Qamar Javed Bajwa said that the appointment of Lt. Gen Johar as the first female army official to have three stars on her uniform is "indeed, a matter of immense pride for Pakistan Army and the country."

"Army Medical College (AMC) has always answered the call of duty during natural calamities, both inland and abroad. Our doctors and paramedical staff have been the frontline warriors against COVID-19, displaying exemplary commitment and resolve for the safety and well-being of the people of Pakistan," he added.

Gen. Bajwa also laid a floral wreath at Yadgar-e-Shuhada at the AMC Centre on this occasion and offered prayers. the Inter-Services Public Relations (ISPR) Director General Major Babar Iftikhar tweeted: "She is the 1st female officer to be promoted to Lieutenant General. The officer has been appointed as 1st female Surgeon General of Pakistan Army,"

Lieutenant General Nigar Johar's story is not that extraordinary except that she is a woman. In 2015, she became the first woman to command in the history of the Pakistan Army. She was given command of a multidisciplinary third-rank care hospital. By 2017 she was only among two other women in Pakistan to reach the rank of major general. In 2020 Johar became the first and only woman in the history of the Pakistan Army to reach the level of Lieutenant-General.[20]

While this is a huge cause for celebration for her and Pakistan, we still have a long way to go before we can actually call this a win. Even though women have been serving in the Pakistani military, since the establishment of Pakistan, in 1947. It was as recent as 2006 that the first women fighter pilot batch joined the combat aerial mission command of Pakistan Air Force (PAF). The Pakistan Navy prohibits women from serving in their combat branch.

Women can't join the armed forces as ordinary soldiers, pilots, or sailors; these posts are only open to men.

Quratulain Fatima, a woman who has served in the Pakistan military says, "In 2001, I was one of the first women to join the Pakistan Air Force (PAF). But the road was not easy."

"We can't have any scandals around here," our course commander told us. "These young men have never seen women in the academy, and they can be very flirtatious." In our conservative society, he insisted, even "a hint of scandal" will suggest that the experiment failed, closing the door to other women who hoped to serve. 

In India, there have been concerns about increasing Islamophobia motivated by Hindu Nationalism. In particular, according to TRT World, the former foreign minister Salman Khurshid had his house attacked by what were likely hindu nationalists. The immediate context was Khurshid writing a book entitled 'Sunrise over Auodhya' in which he compared the HIndutva ideology to ISIS. The context is the BJP ruling over India with a Hindu nationalist ideology which has made many Muslims be concerned.

According to the TRT "The Times of India reported that the group had set fire to an effigy of Khurshid, fired shots and threatened the daughterin-law of the caretaker with a gun. Salman Khurshid, a Muslim from the main opposition Congress party, published a book last month in which he compared the kind of



Hindu nationalism that has flourished under Modi to extremist groups like Daesh." This is what activists are attributing the attack on minister Khurshid's home to.

The background is a Hindutva ideology which many have compared to fascism in the sense that its goal is to make India as Hindu as possible. This is because many of the founders and proponents of the Hindutva ideology regularly praised Hitler and Mussolini who were two the leading fascists in the 20th century.

According to Al Jazeera, there have been other examples of violence against non-HIndus because of Hindu nationalism "Modi's government rejects having a radical "Hindutva" (Hindu supremacist) agenda and insists that people of all religions have equal rights.Uttarakhand state, where the latest incident took place, appears to be a particular hotspot.

Last month, a mob of about 200 people reportedly attacked a church in the state. The local head of the BJP said the building was used for "suspicious gatherings"." Members of the opposition have responded in defense of the former minister including Shashi Tharoor, "is a statesman who has ... always articulated a moderate, centrist, inclusive vision of the country domestically". IAMC Asks Economic Times To Withdraw Defamatory & False Allegations Against IAMC

WASHINGTON, D.C., (November 22, 2021) – The Indian American Muslim Council, an advocacy group dedicated to safeguarding India's pluralist and tolerant ethos, has asked The Economic Times newspaper to withdraw defamatory and false allegations it has published against the organization.

The allegations in "Tripura violence: Police identifies social media conspiracy posts originating outside India," authored by Bikash Singh of supporting Taliban and lobbying with foreign organizations against India in connivance with the ISI."

Ahmed wrote: "We categorically state that IAMC is not linked with JEI (Jamaat-e-lslami) in Pakistan, it does not support the Taliban, and it has no connection with the ISI. The article falsely claims IAMC is part of an "anti-India" lobby."

Noting that the Economic Times report "offered no evidence in support of its defamatory claims," Ahmed wrote the newspaper's "mala fide conduct violates

Ilhan Omar Shares Threats And Hate Received After Lauren Boebert's Anti-Muslim Attack

In the face of increasing hate and Islamophobia, Democratic U.S. Reps. Ilhan Omar, Rashida Tlaib, and Andre Carson condemned anti-Muslim remarks made by their colleague, Republican Rep. Lauren Boebert, during a Tuesday press conference. According to ABC News, they are the only three Muslims in Congress's House of Representatives.

"We may only be three among hundreds serving in Congress, but we are strong advocates that won't shy away in demanding better for our communities. No one deserves to feel hate or racism solely based on one's faith. It's completely unacceptable," Tlaib said.

During the press conference, Omar shared her experience as a Muslim American alongside the consistent hate she has received from colleagues since being elected.

"So, when a sitting member of Congress calls a colleague a member of the "jihad squad" and falsifies a story to suggest that I will blow up the Capitol, it is not just attack on me, but on millions of American Muslims across this country,"



Omar said, referring to Boebert.

Last week Boebert made headlines for a viral video that circulated on Twitter in which she claimed she thought Omar was a terrorist. She also referred to the Muslim congresswoman as a member of the "Jihad Squad." While she issued a nonapology on Twitter shortly after, other footage was found in which she spewed the same anti-Muslim rhetoric at a separate event.

"We cannot pretend that this hate speech from leading politicians doesn't have real consequences," Omar said Tuesday. "The truth is that anti-Muslim hate is on the rise both here at home and around the world." Omar not only condemned the hate but spoke of her own experiences. She shared the "hundreds" of threats she has received following attacks by her Republican colleagues. Omar even held up her phone and played a graphic voicemail in which a person issued a death threat.

Trigger warning: The following transcript and video may contain explicit or violent language and details.

"We see you, Muslim sand n***** bitch," the unidentified man in the voicemail said. "We know what you're up to. You're all about taking over our country. Don't worry, there's plenty that will love the opportunity to take you off the face of this fucking earth. Come get it, you fucking Muslim piece of shit. You jihadist. We know what you are. You're a fucking traitor. You will not live much longer, bitch, I can almost guarantee you that. We the people are rising up, and you will be tried before a military tribunal, and you will be found guilty."

Omar said she received the call on Monday, hours after Boebert refused to apologize to her for her anti-Muslim remarks. The voicemail was one of many threats she has received.

"Condemning this should not be a partisan issue," Omar added. "This is about our basic humanity and fundamental rights of religious freedom enshrined in our Constitution. Yet, while some members of the Republican Party have condemned this, to date, the Republican Party leadership has done nothing to hold their members accountable."

Omar and the other Muslim Congress members urged congressional leaders to take action against Islamophobia and anti-Muslim rhetoric

"We are committed to ensuring a real consequence for dangerous statements that fuel bigotry and incite violence — especially when it is coming from one of our own colleagues" said Carson, who is the dean of the Muslim Caucus. "Rep. Boebert's comments are an insult to this institution and to American ideals. We are NOT anyone's scapegoat."

The three were joined on the podium by Rep. Jamaal Bowman, who is not Muslim but stood with them in solidarity.

"T'm worried about the degradation of our values and of our psychology as a nation as our Republican colleagues continue to fan the flames of racial hate and conflict, and where that is leading us in a post-Trump era," Bowman said.

"Without meaningful accountability for that Member's actions, we risk normalizing this behavior and endangering the lives of our Muslim colleagues, Muslim staffers and every Muslim who calls America home. The House must unequivocally condemn this incendiary rhetoric and immediately pass this resolution. How we respond in moments like these will have lasting impacts, and history will remember us for it," Pressley added.

"There must be consequences for vicious workplace harassment and abuse that creates an environment so unsafe for colleagues and staff that it invites death threats against them," Jayapal said. "There must be consequences for elected representatives who traffic in anti-Muslim and racist tropes that make all Muslims across the country less safe."

While some Republican leaders supported taking action against Boebert, of course others did not agree with keeping their own accountable.

Over the years, the Tablighi Jamat grew as one of the most disciplined and organized apolitical religious movements without the structure of an organization. meeting Wednesday, Minority Leader Kevin McCarthy urged Republicans not to attack each other and to stay united, The Washington Post reported. He used Boebert's non-apology tweet as a reason, claiming it was good enough.

They don't even ask their own members to apologize for things that were said, let alone go after their own members."

Boebert's non-apology came after videos were released in which she called Omar, a Muslim Congresswoman, "a terrorist" and member of the "Jihad squad," not once but on at least two separate occasions.

cilors, whom all identify as white. She served as District 5 city councilor for three years prior to her election. A former refugee, Dhalac came to America over 30 years ago, when Somalia was on the verge of civil war.

The first person she shared the news of her confirmation with was her mother, who reminded her of a prayer she recited to her at the start of high school; the prayer told Dhalac to always be a leader in a community of people of all backgrounds and to use her father's light to guide her.

"It was so beautiful," Dhalac said before Monday's ceremony. "It brought tears to my eyes."

According to the Portland Press Herald, Dhalac grew up in a middle-class family with two brothers. Her father was a former petroleum engineer who lost his job because he was a vocal supporter of Somalia's fight for independence from colonial rule in the 1960s.

"My father really introduced us to the world," Dhalac told the Portland Press Herald, "in read-


